▣ Judicial Economy in WTO Dispute Settlement

Description: This work throws light on different facets of the principle of judicial economy which is a legal principle authorizing the courts to disregard certain claims made in a case, which they consider unnecessary for the settlement of the dispute in question. In particular, how the principle has become a 'necessary evil' under the dispute settlement system of WTO, has been dealt with in this work.
